Chapter 1 | Introduction

This is the 2021 – 2026 Homer Township Parks and Recreation Master Plan. This plan reflects the vision for the future of parks and recreation in Homer Township for the next five years. It serves as a roadmap for future recreation facilities in the Township considering the existing parks, community demographics, natural features and public input. The plan is written in accordance with the State recommended five-year cycle for recreation planning. The content and process follow requirements of the Michigan Department of Natural Resources (MDNR) for a community recreation plan.

According to the National Park and Recreation Association, parks and recreation have three values that make them essential services to communities:

Economic Value

- Parks improve the local tax base and increase property values. It is proven that private property values increase the closer such land is to parks. This increase in private property value due to the proximity to parks increases property tax revenues and improves local economies.
- Parks and recreation programs and facilities provide significant indirect revenues to local and regional economies from sports tournaments and special events such as arts, music, and holiday festivals. Economic activity from hospitality expenditures, tourism, fuel, recreational equipment sales, and many other private sector businesses is of true and sustained value to local and regional economies. This indirect economic value is in addition to direct revenues that are gained from park facilities and programs.

Health and Environmental Benefits

- Parks are the places that people go to get healthy and stay fit.
- Parks and recreation programs and services contribute to the health of children, youth, adults, and seniors.
- Parks and protected public lands are proven to improve water quality, protect groundwater, prevent flooding, improve the quality of the air we breathe, provide vegetative buffers to development, produce habitat for wildlife, and provide a place for children and families to connect with nature and recreate outdoors together.

Social Importance

- Parks are a tangible reflection of the quality of life in a community. They provide identity for citizens and are a major factor in the perception of quality of life in a given community. Parks and recreation services are often cited as one of the most important factors in surveys of how livable communities are.
- Parks provide gathering places for families and social groups, as well as for individuals of all ages and economic status, regardless of their ability to pay for access.
- Parks have a value to communities that transcend the amount of dollars invested or the revenues gained from fees. Parks provide a sense of public pride and cohesion to every community.

This document is intended to serve as a guide in the planning for future park and recreation opportunities, services and implementation. Population shifts, new development and changing attitudes towards leisure have added additional pressures to the community's existing parks and recreation system, thus increasing the need for both short and long-range planning.


Recommendations such as land acquisition, and facility expansions and construction, and even the design of park improvements, will require additional study or involvement of residents in order to address the site-specific details. This plan lays the foundation upon which these activities can build.

Implementation strategies are identified over the next five years, at which time the plan will again be updated. The delineation of these improvements will aid Homer Township in grant solicitation from the DNR and other granting agencies, as well as with long range capital improvement budgeting. Additionally, during the next five years, it is important for Homer Township to reference the plan and make appropriate priority adjustments as conditions change and funding opportunities arise.

Chapter Two | Community Description

Regional Setting

Homer Township is located in the heart of the Great Lakes Bay Region, just west of the City of Midland. It is bordered by Lincoln Township to the north, Lee Township to the west, Mt. Haley Township to the south, and Midland Township and the City of Midland to the east. The Township has three rivers that flow through it: the Pine, the Chippewa, and the Tittabawassee. In addition to the rivers, the Township is largely wooded and residential with sections of wetlands and the Chippewa Nature Center, a unique regional recreation resource.

Demographics

Analyzing the demographics of a community helps determine the quality and quantity of parks and recreation facilities necessary to serve Homer Township residents. The following data is from the 2000 and 2010 U.S. Census and the 2018 American Community Survey estimates. The following section compares Homer Township to adjacent communities for a better understanding of both, the Township's population, and also how that population compares to similar localities.

For almost 20 years, the population in Homer Township has been steadily hovering right around 4,000 people. In 2010, the population was the highest at 4,009. The American Community Survey, an annual survey completed by the Census Bureau, predicts the current population of Homer Township at 3,987. However, the ACS is an estimate and there won't be a full population count until to 2020 Census data is released. In comparison, Midland County and Michigan have also had steady population numbers, with the difference that Homer Township and the State lost population between 2000 and 2010 and Midland County gained population.

There are certain demographics that are more pertinent to parks and recreation planning than others. Those include population age, rental households, median household income and the poverty level. The following graphic is a discussion of those four characteristics related to parks and recreation planning in Homer Township.

Physical Characteristics

Transportation Network


The transportation network in Homer Township is made up of several different types of roads and modal options. M-20 bisects the Township separating the northern and southern half, the Township has a network of County and private roads. Due to the heavily wooded areas and the three rivers in the Township, the layout of the transportation network is not the standard mile grid like other Michigan townships. Just outside of the northeast corner of the Township boundary there is a US 10 interchange, connecting Homer Township to the Statewide highway network. In addition to the auto-oriented transportation network, the Pere-Marquette Rail Trail traverses the northeast corner of the Township. The Pere-Marquette Rail Trail connects into the Cityowned pathway along Poseyville Road and Midland Township Path. Eventually, this path will extend to Gordonville Road in Midland Township and will connect into the Great Lakes Bay Regional Trail. This is a regional trail system that connects Bay, Saginaw, and Midland Counties.

Land Use and Natural Features

A resource inventory can be used to identify open space areas that may be desirable for protection and/or public access through acquisition or other means. Homer Township is rich in natural resources. The land use and natural features in Homer Township are largely wooded rural or undeveloped land. There are three rivers that flow through the Township and converge to the east in the City of Midland, the Tittabawassee River, the Pine River, and the Chippewa River. After they converge, they continue southeast as the Tittabawassee River and flow toward Freeland and Saginaw County. Each river corridor provides unique fish and wildlife habitat in the Township. The rivers also serve as recreation for cancers and kayakers.

The wooded land in the Township is mostly privately owned, there is no State Forest land in Homer Township. In general, the forest is made up of deciduous trees with pockets of evergreens throughout the Township. There are also areas of wetlands along the northern border of the Township and along the rivers. Due to the presence of so many rivers, there are parts of the Township that are in the floodplain. The majority of these parcels follow the riverbeds, but there is a larger floodplain area where the Chippewa and Pine Rivers converge. NATURAL FEATURES MAP




Administrative Structure

How Parks and Recreation Function in Homer Township

The Homer Township Board, with input from the Parks and Recreation Committee, carries out the management of recreation in the Township. The commission consists of nine members, two representatives from the Township Board, and members of the public. Each member receives his or her appointment from the Township Board. The Parks and Recreation Committee is an advisory committee to the Township Board. The Committee meets quarterly to review parks and recreation concerns in the Township. The Township hires **1 PT seasonal and 2 FT public works** employees to maintain the parks. The Committee, with assistance from the Planning Commission, created this Parks and Recreation Master Plan. The Township has not received any grants in the past.

FINANCING AND BUDGETS

The parks and recreation facilities and programs in Homer Township are funded through the Township general fund and rental fees. Rentals of the park pavilions provide some additional revenue to the parks. Funds for capital improvements such as new playground equipment have been allocated from the general fund in the past. Budget information for Homer Township's Parks and Recreation is shown in Table 2 below.

Cooperative Relationships

The Township has several cooperative relationships with different community groups for use of both parks. They are as follows:

- Bullock Creek High School Soccer Homer Township Park soccer fields
- Bullock Creek Little League Softball and Baseball fields in Homer Township Park for girls softball and boys baseball.
- Michigan Mase Advanced Athletics Township Hall Park fields for flag football
- Archery Club Tournaments
- Radio Club HAM Radio gatherings
- Potential Future Partnership Midland Lacrosse League to use fields in Homer Township Park

Each of these groups keep their own participation records. The Township is not involved in programming.

Role of Volunteers

Volunteers are a regular part of parks and recreation in Homer Township. The volunteers are affiliated with each of the different organizations the Township partners with for use of the parks, see cooperative relationships above. These volunteers run their respective programs and the facilities they use in the parks.

Chapter Three –

Recreation Inventory

This chapter is an inventory of the Township's existing park system, which includes a record of the current recreation amenities provided at each facility. The inventory also includes a description of some key recreational facilities that are available outside of Homer Township.

Developing a complete inventory of recreation facilities is an essential component of a five year Parks and Recreation Master Plan as it provides a base of information to use in developing the Action Plan. Understanding what facilities are available to Homer Township residents will assist decision-making in the future.

The inventory covers the following components:

- Public Parks and Facilities (managed or owned by Homer Township)
- Undeveloped Park Land
- Local & Regional Parks and Facilities

Accessibility

Creating a park system that is safe, accessible, and usable to all individuals, including those with disabilities, is essential. A grading system has been developed by the Michigan Department of Natural Resources (MDNR) to rate parks and facilities simply and effectively on their ease of use and accessibility for handicapped residents. The standards are based on the American Disabilities Act (ADA) guidelines. The accessibility grading system uses a five-point system ranging from one (none of the facilities/park areas meet accessibility guidelines), to five (the entire park was developed/renovated using the principals of universal design). See Table 3.

An ADA compliance assessment of parks owned and operated by Homer Township was conducted during the summer of 2020 by the planning consultant and was verified by Township staff. The assessment consisted of a visual inspection of each park regarding access and circulation in relation to the park facilities. Homer Township is dedicated to improving accessibility at each of its parks when improvements are made. This includes accessible parking, paths, restrooms, activity areas, amenities, and signage.

Type of Parks

Classifying parks into categories helps define their role in the overall Plan, demonstrates their relationship to each other, highlights deficiencies, helps to develop an action plan, and assists in allocating funding. The classification system described below is adapted from the National Recreation and Parks Association guide recommended by the MDNR for recreation standards. It describes park types based on size, service area, facilities, and use groups.

Mini Park

Parks are less than one acre in size and is less than 1/4 mile from a residential setting. Access is primarily pedestrian and by bicycle, with no on-site parking. It is used to address limited, isolated, or unique recreational needs.

Community Parks

Parks serve a broader purpose than Neighborhood Parks. They have more amenities and usually serve the entire community. They are larger in size than Mini-Parks or Neighborhood Parks. Access is primarily vehicular and parking is included on-site.

Neighborhood Park

Parks serve as the recreational and social focus of a neighborhood. They are easily accessible to neighborhood populations and geographically centered within safe walking distance and have bike access. Their service area is generally 1/4 to 1/2 mile.

Special Use Park

Parks generally cover a broad range of parks and recreation facilities oriented toward single-purpose use.

Homer Township Parks

The Township owns and operates two developed parks and one undeveloped property. These three areas total 36 acres of recreation land. The following section includes an in-depth discussion for each park. A park location map is included at the end of this chapter. This inventory was completed in the summer of 2020 by the planning consultant.

Homer Township Park is the largest and most developed of the recreation facilities in the Township. This is the Township's main park. In addition to day use activities, the park is also home to softball diamonds which serve the Bullock Creek school system and a local little league program. The southern end of the park is fully developed, however the eastern area of the park is still open play area and the Township is looking to design a park concept plan for this area in the future and use that plan as a guide for future DNR grant applications and park projects.

This property is directly across from the Nature Center property and the Parks and Recreation Committee sees this as a possible connection opportunity for the future.




Trails

Communities across the United States are creating regional trail systems in both cities and rural areas to provide a higher quality of life for residents. In fact, of all the states, Michigan has the largest rail-trail system. Even more impressive, these trails cover long distances, which is uncommon in other states. Trails give residents the opportunity to be more active and healthy, safer while walking or biking on the roads, provide additional ways to experience their community, and give all users the option of increased mobility in different modes of travel.

Historically, the roads in Homer Township have been designed with only automobile traffic in mind. However, communities are now working toward creating a network of trails and roads that are accessible to several forms of traffic. This often means sharing the existing road right-of-way with bikes or having a separate pathway running parallel to the road which is designated for non-motorized use and connects regional centers.

Why trails are important

While trails can be a challenge to implement, their positive effects on a community cannot be disputed. It has been proven that trails create a pride of place and sense of ownership in Michigan residents. Trails are also an important driver in the local and regional economy, increase property values, and provide safe and healthy recreation options.

The growing trail trend in Michigan is also reflected in Homer Township's residents' opinions. On the whole, they feel trails and pathways would be an asset to their community. In the public input survey, respondents emphasized how important non-motorized pathways and trails are to the residents.

Trail users have a measurable impact on the local economy. Working with the surrounding townships and other jurisdictions is an effective way to connect with existing systems and expand the non-motorized pathway infrastructure. These projects would create a long-term, valuable investment in the community and the opportunity to connect the Township to others in the region This would promote economic vitality, encourage a healthier lifestyle in their residents, and create a safer travel environment.

Homer Township Trails and Pathways

The Parks and Recreation Committee recognizes the importance of planning for trails in Homer Township. The Township is fortunate to be close to several existing trail systems and the Committee sees a few key connection points that would connect Homer Township residents to the larger existing trail network.

The Pere-Marquette Rail Trail traverses the northeast corner of the Township, see the Recreation Map at the end of this chapter. This trail connects Midland and Clare Michigan along the old Pere-Marquette railbed. It is 30 miles of paved trail. The trail passes right through Homer Township and is a great opportunity for residents who are looking to walk or bike. There was some interest in the community input survey for a trailhead in Homer Township so residents can more easily access the trail. The Committee is also interested in looking into the possibility of a trailhead.


A portion of the Chippewa Nature Center is located in Homer Township. The Chippewa Nature Center is a unique recreation provider in the Mid-Michigan region. The nature center began as a collaboration between Dow Chemical Company Foundation and The Midland Nature Club. Dow reserved 200 acres between the Pine and Chippewa Rivers. Eventually, Dow donated the property to the Nature Center which has been steadily growing and it is the largest private non-profit nature center in the United States. In total the Nature Center has more than 1,500 acres, 40 staff members, and over 70,000 visitors a year. In addition to beautiful natural land, the Nature Center also offers programming.

The Nature Center has a robust trail network throughout the property with more than 19 miles of trails. See the Nature Center's trail map below. The trail network in the Nature Center is also connected to Midland's parks and pathways system. As this facility is located partially in the Township, it provides a unique recreation opportunity for residents. The Committee is interested in connecting to this resource. If the Township can connect a non-motorized pathway from the park or Township Safety Building, it would connect Homer Township residents to the Nature Center and the extensive park and recreation system in the City of Midland.

If Homer Township could connect to the Nature Center, it would also be able to connect residents to the pathway system that extends south of the City. The City has a path that runs to Overlook Park and from Overlook Park, the Midland Township trail extends south along Poseyville. Midland Township is currently planning to extend that trail to Gordonville Road and there are funds in place from Dow and plans to extend the Trail to Freeland along River Road and connect into the Great Lakes Bay Regional Trail. There is an extensive trail system in place just outside of the borders of Homer Township, and if the Township can make a few key connections to that network the residents will have significantly more recreation options.

Chapter Four

Community Input Summary

One of the most important aspects of a community's Parks and Recreation Master Plan is a detailed review and analysis of the resident's opinions regarding the future of their parks and recreation system. Homer Township released a survey designed to gather the information to guide the Township's parks and recreation program for the next 5 years. A complete tabulation of the results is available for review in Appendix A. The text below provides a description of the significant results.

Overall, the survey had 14 questions, and there was a total of 168 responses, with a 100% completion rate. The Township advertised the community input survey on the Township website, sent out mailers to Township residents, published an article in the Midland Daily News, and put out a targeted advertisement on Facebook. The online survey was available in summer of 2020, at www.homertownshipparksurvey.com.

A second means of input was provided during the required public review period. The draft plan was available for review at LOCATION and on the LOCATION from DATE to DATE. A third opportunity was provided at the public hearing on DATE at LOCATION.

Respondents

Of the 168 respondents, 128, or 76.6%, were residents of Homer Township, 21% were residents of Midland County, and 2.4% lived elsewhere. The age range of the survey respondents was representative of almost all the age groups in Homer Township. The age groups and survey participants are listed below:

- Under 19: 0.6%
- Ages 19 29: 12.6%
- Ages 30 39: 32.9%
- Ages 40 49: 22.2%

- **Ages 50 59:** 15.6%
- Ages 60 69: 14.4%
- Ages 70 and older: 1.8%


Most respondents visit Homer Township parks with their children (68%), then spouse (54%) other popular groups included pets, friends, alone, or grandchildren.


The following questions revolve around the current status of parks in Homer Township and the future of parks and recreation.

Why do you visit parks in our community? Please check all that apply.



What additional amenities would you like to see at Homer Township Park? Please check all that apply.




What additional amenities would you like to see at Township Hall Park? Please check all that apply.



Homer Township owns property near the corner of Chippewa River Road and Sandow Road along the Chippewa River. In the future, this property could provide river access for fishing or a canoe/kayak launch. The survey respondents were asked what the priority should be for parks and recreation over the next 5 years. The ranking is as follows:

- 1. Upgrade/Add amenities to Homer Township's existing parks.
- 2. Maintain Homer Township's existing parks and recreation facilities.
- 3. Acquire additional park land.

Most respondents would like to focus efforts on improving the existing parks by adding new amenities and then maintaining the existing facilities. Priority 3 was to acquire new land.

What do you like best about Homer Township parks?

This was one of two open-ended questions in the survey. In total, there were 103 responses to this question. The most common responses were:

- The parks are close to home
- The parks are clean and well maintained
- The parks are safe
- The parks have large open spaces
- The parks are not too busy

What is one thing you would do to improve Homer Township parks?

This was the second open-ended question which had 117 responses. The most common answers were:

- Walking trails
- New play equipment for multiple age groups
- Update restrooms
- Bike paths
- Splash pad
- Access to water

Chapter Five | Goals, Objectives, and Action Plan

Developing goals and objectives is an important part of the recreation planning process. Overall the Township wants to provide quality recreation opportunities for the community it serves. More specific goals, like those listed below, must be based on public input, the demographic characteristics of the population served, and other physical and environmental characteristics of the Township.

Read this chapter with the following principles in mind. Goals are the broadest level, they are overreaching and general. By nature, objectives are the measurable items which carry out the purpose of a goal. Action items are the last level, and they identify specific projects and programs to be pursued over the next five years. Action items can include organizational, staffing, programming, public information, and operation and maintenance actions. The Parks and Recreation Committee, with assistance from the Planning Commission, formulated the following goals and objectives based upon the characteristics of the overall community, the online survey, and other factors.

Goal 1: Provide safe, broad, community-based recreation opportunities that improve the overall quality of life for all residents of Homer Township.

Recreation opportunities geared toward different age groups and user types can help improve the health, fitness, and overall quality of life for Homer Township residents. To leverage limited local funding, the Township wishes to seek grant opportunities to fund capital improvement projects for the parks.

Objective: Develop recreational facilities that are accessible for users of all abilities.

Objective: Provide for activities and experiences that can be enjoyed together with persons of multiple ages.

Objective: Monitor trends and new emerging recreational opportunities that are growing in popularity.

Objective: Provide both passive and active recreation options.

Objective: Seek and apply for grants to support new recreational opportunities through grant agencies such as the Michigan Natural Resources Trust Fund, the Land and Water Conservation Fund, and local foundations.

Goal 2: Improve/provide barrier free access or universal design standards to all recreation facilities.

All parks and recreation facilities should be designed to be inclusive of all user groups. Homer Township recognizes the importance of this and places a high priority on ensuring accessibility with current and future park amenities. Where possible, the Township will work to ensure universal accessibility in all future projects.

Objective: Provide equal recreational opportunities for people with disabilities.

Objective: Improve barrier-free access to all existing recreation facilities.

Objective: Where possible, strive to meet universal design standards with new park amenities and facilities.

Goal 3: Improve walking and pedestrian opportunities throughout Homer Township

Non-motorized trails provide a wide variety of users with opportunities for exercise and access to previously undiscovered scenery. These benefits are making all forms of non-motorized transportation increasingly well-received across the United States. Expanding the community's non-motorized corridor network will ensure an accessible recreation option for current and future residents.

Objective: Add walking and multi-use pathways in Township parks.

Objective: Investigate the potential for a regional multi-use pathway that is accessible for Homer Township residents and links to a regional path network.

Goal 4: Develop and strengthen water-based recreation opportunities.

Homer Township has three rivers that flow through it, they are defining features of the Township. Based on the survey responses, the residents of Homer Township are very supportive of more access to these bodies of water. They have potential to provide a variety of recreation options for residents.

Objective: Provide access to waterways in Homer Township for recreational activities such as fishing, canoeing, kayaking, and swimming.

Objective: Preserve and protect water-related resources in Homer Township

Goal 5: Investigate new opportunities to acquire properties for park land and open space as they become available

Community input survey results clearly demonstrate that Homer Township residents prioritize new facilities in existing parks above expanding the parks and recreation system. Still, opportunities may arise for additional park land acquisition and expansions of existing facilities. Examples could include parcels adjacent to the existing parks or parcels connected to the Chippewa Nature Center. Depending on the circumstances the right parcel could open up recreation opportunities to Homer Township residents.

Objective: Acquire additional park land in various open spaces in the Township including parcels with access to the Chippewa River.

Objective: Preserve and protect open space and other important natural resources in the Township

Objective: If desired, acquire property adjacent to existing park facilities.

Goal 6: Increase public awareness and knowledge of the recreation opportunities in Homer Township

The Township has two parks, and 53% of survey respondents indicate they visit the parks more than five times a year, but the Parks and Recreation Committee is aware that not all residents of the Township are aware of or actively use the parks. The Committee believes it will be important in the upcoming years to ensure the parks and events at the parks are more widely advertised so Homer Township residents can take advantage of this great resource.

Goal 7: Foster regional collaboration with local groups to improve recreation options in Homer Township

Homer Township is in a key location in Midland County. The Township is just west of the City limits and therefore has the potential to greatly benefit from the extensive parks and recreation system in the City of Midland and the region as a whole. With strategic planning and a few key amenities, Homer Township has the opportunity to become connected to the City's parks and the regional trail network.

Objective: Explore partnerships with local sporting groups for park usage

Objective: Build relationships with other regional partners like the Chippewa Nature Center

Objective: Look to partner with neighboring communities to provide more recreation opportunities for Homer Township residents.

Action Plan

This section of the plan introduces an action program that will guide the park and recreation activities of the Township for the next five years. Homer Township developed a 5-year Action Program to work toward accomplishing the goals and objectives outlined above. The project list in not a fixed element and it is neither all-inclusive nor exclusive. The Action Plan reflects the results of the input received from the online survey and the decision-making efforts of Township officials. Future circumstances, especially availability of funding, may change priorities or require reprioritization of items. A full list of funding sources for parks and recreation projects can be found in Appendix B.

Each action item relates to one or more goals described above. Each item has been a priority of 1 -5, with 1 being the most important and 5 least important. See the chart on the following page.

Chapter Six |

Summary and Adoption

In an effort to provide quality recreational opportunities for its citizens, Homer Township has created this Parks and Recreation Master Plan to guide the development of community parks and recreational facilities and locations over the next five years. This Plan is an important effort by Homer Township to establish recreational goals and objectives for the community. The Plan will also provide the Township eligibility for grants from the MDNR to assist the community in reaching its recreational goals. Homer Township contracted with Spicer Group of Saginaw, Michigan, to assist them with completion of the Parks and Recreation Master Plan. The consultant met with the Township Parks and Recreation Committee, Planning Commission, and Board during the development of the Plan.

Data was collected about the community including maps, demographics, park information and an inventory of existing facilities. This data was collected from Township staff members as well as various web sites and through field observations.

Community input was collected via a community input survey held in the summer of 2020. Based on inventoried information and the community input, the Township developed goals and objectives for parks and recreation in Homer Township. The Township finally developed and prioritized an action plan to accomplish the goals and objectives of the Plan.

The consultant completed the draft Parks and Recreation Master Plan document, and it was made available for review at the LOCATION on DATE. This reviewing opportunity was advertised in the local newspaper and the Township website. The final opportunity for community input occurred at the advertised public hearing held prior to adoption of the Plan. This hearing was held at meeting on DATE. The Township Board adopted the Recreation Plan by resolution at its regular board meeting on DATE.

A copy of the advertisement for the public hearing, copies of meeting minutes for both the public hearing and the regular board meetings, as well as the resolution of adoption of the Plan by the Township Board, are included in Appendix C.





What is your relationship to Homer Township?




When you visit the parks, who do you normally visit with?





How often do you visit Homer Township Parks?





Michigan Recreation Passport Grant

Michigan Department of Transportation - Transportation Alternatives Program

- Objective improve or create shore-based Great Lakes recreational access.
- Must be located on the Great lakes or lower portions of major tributaries

- Due dates vary.

Michigan Coastal Management Grants

Objectives

- Protect, manage and restore coastal communities and habitats
- Restore historic structures
- Revitalize urban waterfronts
- Increase recreational opportunities along Michigan's Great Lakes coast
- Applicant must be a coastal unit of government
- Maximium grant request \$100,000
- Match requirements 50% (some flexibility in match for non-construction projects that result in changes to local master plans or zoning ordinances, regional greenways, or include conservation planning)
- Eligible projects
 - Studies, Designs and Land Use Plans must have a direct connection to coastal planning and/or resource protection.
 - Construction boardwalks, trails, lighthouse preservation, habitat restoration, scenic overlook, etc.

- > Most grants are provided on a reimbursable basis.

- Grant applications can be complicated, detailed and competitive. Make sure your grant writer is familiar with the grant and funding source. Learn as much as possible ahead of time to know if your project has potential for funding.
